#### **GREETINGS FROM THE CHAIR**

As 2023 comes to an end, I reflect on **how far Bayfield Area Trails (BATs) has come** since we signed the <u>Memorandum of Understanding</u> in 2020. I am inspired and grateful to see the community of volunteers and trail supporters who love and care for the trails. The **generosity of our community and granting agencies has been overwhelming**; especially in support of the bridge across Pikes Creek for the Pileated

Woodpecker Trail! In 2023, a total of over \$175,000 in donations and grants came through our BATs partners to enhance and expand the trails that we all cherish and enjoy. Some of these funds will be carried over into 2024.

As an all-volunteer organization, our success depends on people who are willing to give their time and talents. As such, the capabilities and knowledge of our volunteers continue to grow so that we are able to take on more challenging projects in a more sustainable manner. We do this by following a model of 1) Planning New Trails and Securing Access; 2) Maintaining and Building Trails; 3) Building and Sustaining Organizational Capacity; and 4) Communicating with all who are interested. Amazingly, during 2023, 45 folks volunteered on 10 projects and donated 1340 hours on field projects and 1250 hours on committees, public information/communications, and project planning and coordination. With nearly 25 adopters, our Adopt-a-Trail program is up and running smoothly to keep trails safe and clear.

Most gratifying of all, is encountering people of all ages out on the trails...smiling and sharing time with others in the beauty of our wonderful north woods. It warms my heart to hear your positive feedback and enthusiasm about how the BATs' efforts have enhanced our lives and community. These trails connect us with nature and give us physical, mental, and spiritual health. I hope you find this as inspiring as I do. Thanks to everyone who has blessed us with these enriching gifts!







#### TRAIL USE STATISTICS

#### **BUILDING & SUSTAINING ORGANIZATIONAL CAPACITY**

#### TRAILS SUBCOMMITTEE (TsC)

The TsC Mission: To assist with maintaining and enhancing existing trails and developing new trails with the support of our wonderful donors and trail volunteers. To accomplish this, the TsC leads the following activities:

- 1. Coordinate the Adopt-a-Trail program to monitor trail conditions and conduct basic trail maintenance.
- 2. Plan and implement volunteer training.
- 3. Administer volunteer release forms, and maintain a current list of volunteers.
- 4. Identify project leaders and develop field project plans for projects.
- 5. Assist with planning and hosting the annual trails forums.
- 6. Seek volunteer feedback to help improve the volunteer experience and improve trail work

**Upcoming activities:** There is an ad hoc subcommittee developing best practices for trail maintenance, management, and signage. Another ad hoc subcommittee is working with the Bayfield County Lands Records Office to develop accurate and accessible trail maps to be used via mobile apps.

#### THE ADOPT-A-TRAIL PROGRAM (AAT)

The Trails Subcommittee coordinates an active Adopt-A-Trail program with 23 trail adopters who monitor and do basic trail maintenance on 35 trail sections. During 2023the AAT program became more automated, streamlined, and organized.

Trail adopters visit and maintain their trail sections at least three times during the snow-free season. As time permits, adopters are encouraged to visit trails through the season to maintain good conditions and report issues in a timely manner. Using hand tools, they perform basic trail maintenance. Land managers of trail sections and the TsC are alerted if there is a trail condition that needs urgent attention. We have openings for new adopters! #### **2024 PRIORITIES**

#### MAINTAIN AND ENHANCE EXISTING TRAILS: emphasize trail maintenance in 2024

**Brownstone Trail:** Finalize restoration designs; continue fundraising; conduct invasive species control and native plantings

Frog Bay Trails: Organize volunteers to assist Red Cliff TNR with spring maintenance

Siskiwit Preserve: Focus on signage/mapping, and site cleanup

Salmo Trail: Install interpretive and orientation signs/map at trailhead kiosk.

Big Ravine Headwaters Trails: address drainage; add boardwalks; continue mowing

**Big Ravine:** Assess the potential need for bridges on the Gil Larsen Trail; West Rim Trail maintenance; replenish gravel on upper East Rim Trail.

Ongoing maintenance identified by BAT Comm. members and Trail Adopters

**Easements** for existing Big Ravine trails

#### **DEVELOP NEW TRAILS (with TsC support)**

**Complete the Pileated Woodpecker Trail** 

Jerry Jolly Trails: Coordinate with Bayfield County to re-establish trail from the "Overlook" to the Jolly Long.

Construct Big Ravine Sweeny Loop (if approved): link Martin Rd. to end of Chipmunk via Sweeny Ave. R/W

Fire Hill: Assist Bayfield County with trails planning and implementation.

#### PLAN NEW TRAILS & SECURE ACCESS (working with willing landowners)

Support Red Cliff on the TAP-funded feasibility study of trails, including Red Cliff to Bayfield link.

**Chequamegon Rd. to Salmo Trail:** Pursue possible easements for a public connection to complete the Brownstone Trail.

Explore possible new trails in the Big Ravine to create loop(s)

Continue to explore potential trail connections on Bayfield Hill, Orchards, etc.

Work on new Bayfield Area Trails "master plan" based upon input from Trails Forum & Trail User Survey

Big Ravine Coordinated Plan: consider a coordinated integrated management plan with City & Town.

Initiate follow-up on interest expressed at 2023 Trails Forum about **mountain biking around Fire Hill and mushing trails** 

#### COMMUNICATION AND OUTREACH: Communications Subcommittee (CsC) lead

#### **Conduct Trail User Survey and Socioeconomic Study**

Improve availability of **online map information**, including QR codes, **master map**, and links to other trails

Develop and implement standardized coordinated maps and trail directional and interpretive signage

Recruit additional members and strengthen the CsC to be self-sustaining. Develop **capacity for graphics**, signage, photography, and content for website.

#### **BUILD CAPACITY FOR TRAIL PROJECTS: Trails Subcommittee (TsC) lead**

Place an emphasis on recruiting and developing younger volunteers for long-term continuity

Develop and implement standard volunteer and trail adopter training.

Develop maintenance and management standards & guidelines.

#### **ESTABLISH A SUSTAINABLE ORGANIZATION**

Maintain fiscal sponsorship with Recreation & Fitness Resources. Consider other long-term strategies.

Work on a strategic multi-year plan with priorities.

Develop **funding needs** and fundraising strategies & procedures based on priorities.


